Commemorating the 23rd Anniversary of the Singh Decision

Every year on April 4th we commemorate and celebrate the 1985 Supreme Court Singh Decision, which expresses the best in Canadian society's wish for hirness and justice. The ruling states that everyone physically present in Canada has rights under the Canadian Charter of Rights and Freedoms.

This decision led to the formation of the Immigration Refugee Board (IRB), so that today every Refugee Claimant has the right to an Oral Hearing, to make his/her case before the decision maker.

2. Refugee Appeal Division

In Canada, refugee claimants have no appeal on merits of a negative decision on their case. An appeal exists in Canadian law, but the government has not implemented it. A bill currently before the Senate would give refugees their appeal rights. Call Senators today to pass Bill C-280 on the Refugee Appeal Division!

3. Family Reunification

Refugees frequently face years of waiting before being reunited with family members still overseas. Demand drastic reduction in processing time. Endorse the Canadian Council for Refugees Manifesto on Family Reunification at:
