Immigration detention statistics 2015

The following statistics are derived from data on detention reviews held in 2015 by the Immigration Division of the Immigration and Refugee Board (IRB). The data was acquired by the Canadian Council for Refugees through an Access to Information Request.

The statistics do not cover all people detained, since some are released by the Canada Border Services Agency before they are brought before the IRB for a detention review.

Although not complete, these statistics are useful in providing some information on people in detention, given the shortcomings in the detention statistics held by the Canada Border Services Agency.

Children in detention

At least 82 children were detained in 2015. This does not include children who were in detention accompanying a parent, as "guests". Children were detained for an average of 23 days. Altogether these children spent a total of 1,922 days in detention.

The data does not indicate which detainees were refugee claimants, but does indicate whether the hearing was held in private, which the law requires in cases involving refugee claimants. It is possible that in some cases not involving refugee claimants the Immigration Division decided to hold a private hearing, but such cases are not likely to be many. We are interpreting private hearings as indicating that the persons were refugee claimants.

85% of detained refugee claimant children were detained in Montreal (at the CBSA detention centre in Laval), representing half of the minors detained in Montreal.

In both Montreal and Toronto, the children who were refugee claimants spent on average longer in detention than the children who were not refugee claimants.

Only one child was detained on grounds related to danger to the public or security. The others were detained on the grounds of identity not being satisfactorily established, or flight risk, or a combination of the two.

All detainees released or removed

There were in total 4,258 detainees released or removed in 2015 following a detention review. This number does not include people who remained in detention at the end of 2015 or people who were released from detention before a detention review.

The 4,258 individuals had collectively spent a total of 232,266 days in detention by the time they were released or removed.

Refugee claimants make up the highest proportion of detainees in Montreal, at 26% of all detainees. Refugee claimants detained in Toronto spend on average much more time behind bars than in other regions. At an average of 99 days, detained refugee claimants in Toronto are also detained longer than non-refugee claimants in Toronto.

The vast majority (93%) of refugee claimants detained are detained on grounds of identify or flight risk, with no allegations that they represent a danger to the public or a security risk. These refugee claimants each spent on average 51 days in detention, and together were detained 32,937 days.
