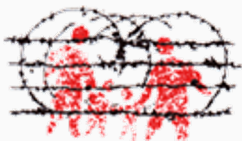

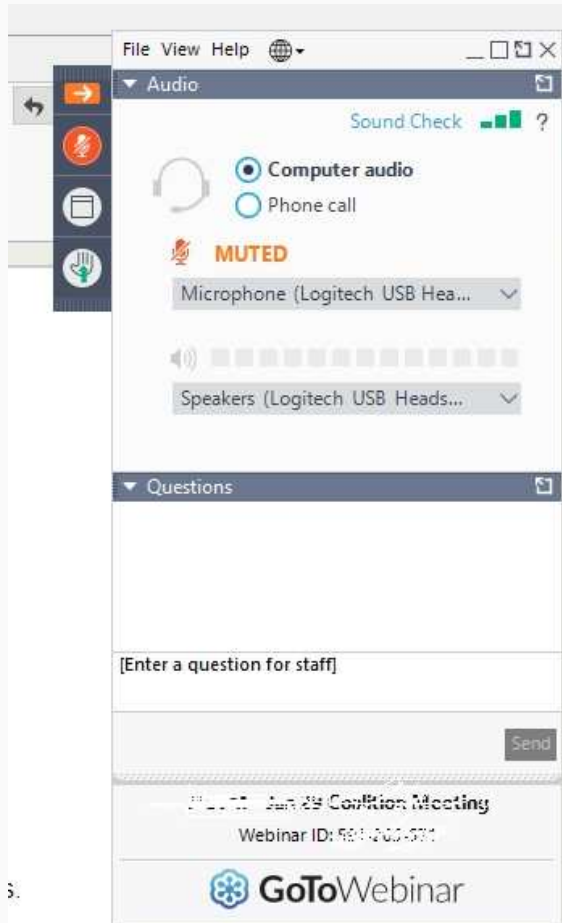
The Canadian Council for Refugees recognizes the Indigenous Peoples of Canada as its original inhabitants.

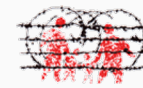

# CCR Advocacy Priorities

- **Root Causes:** Recognize and address systemic inequalities that are the causes and consequences of trafficking
- **Protect Rights:** Protect the rights of trafficked persons and those at risk (fix laws and policies that create barriers and provide better rights protection)
- **Permanent Status:** Implement legislative changes to ensure there is permanent pathway to protection
- **Access to Justice:** Ensure effective access to justice (stronger human-rights based recourses, law reform that is non-punitive and recognizes trafficking in all its forms)
- **Access to Services:** Ensure universal access to public services (healthcare, education, childcare, psychosocial support, etc.)



# Today's calls to action

The federal government must:

Make VTIP-TRPs accessible to trafficked persons in a way that reflects how people are coerced and exploited in Canada. This grounded understanding of international trafficking in Canada needs to be consistently applied across all provinces.

Collaborate with front-line workers who have expert understanding of how recruitment, deception, fraud, coercion are means to exploit people in Canada.

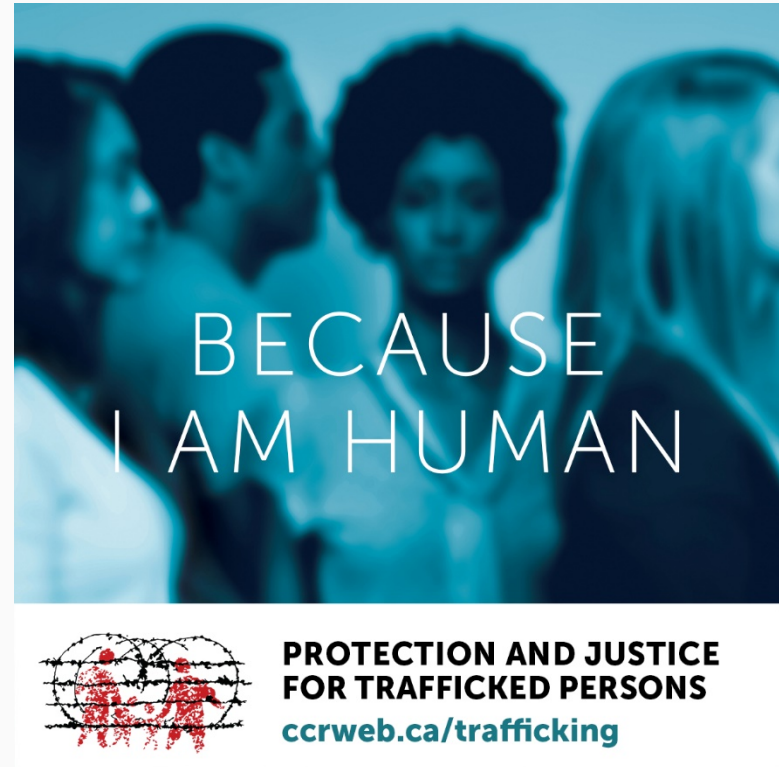

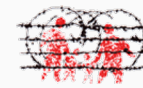

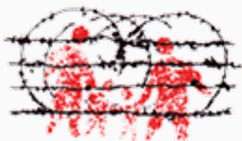
