# Immigration and Settlement

This Working Group (WG) provides a forum to exchange information, network and develop policy positions on issues related to the settlement & integration of refugees, immigrants, and other migrants in Canada, including:

- Provision of settlement services;
- Broader social justice context related to newcomers in Canada, for example: systemic racism, racialization of poverty, employment and income security, housing, mental and physical health, family reunification, and equitable access to services and more.

### ● Co-chairs

They are responsible for ensuring that the work agenda is moved forward, and that Resolutions and Action Items are acted upon.

### ● Steering Committee

The Steering Committee is intended to engage the broad base of expertise within the WG membership to advance its priority issues and initiatives (Resolutions, Action Items, new initiatives and strategic thinking, preparation for consultations, attendance at meetings with government, etc.). The committee works closely with the Co-chairs.

#### Housing Network

This Network provides an organizing space for CCR members to collectively advocate for safe, secure, and affordable housing for all newcomers to Canada, such as refugees, migrant workers, those with precarious status and non-status, among others.

#### Youth Network

The Youth Network uses a gender justice and anti-oppression approach to create youth-led spaces for young newcomers and refugees to voice the challenges they face as newcomers and collectively share ideas on how to address these barriers.

#### Anti-Trafficking Committee

Created in response to the growing concerns about the human trafficking of migrants in Canada, the ATC identifies promising practice interventions and advocacy strategies, assists internationally trafficked people in processing trauma, and pinpoints policy barriers.
